

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to frankubuilds.com and frankuhomes.com and Franku Builds LLC, Franku Homes LLC, and Franku Public Adjusters LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Franku Builds LLC, Franku Homes LLC, and Franku Public Adjusters LLC include frankubuilds.com and frankuhomes.com and Franku Builds, Franku Homes, and Franku Public Adjusters. By using the Franku Builds, Franku Homes, and Franku Public Adjusters website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Franku Builds, Franku Homes, and Franku Public Adjusters may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title
- Resume

If you purchase Franku Builds, Franku Homes, and Franku Public Adjusters's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
